4 to serve the same upon the Adverse Party, and upon service, file return of service form with the  
5 court.

6 **VIOLATION OF THIS ORDER IS A CRIME**

7 **You, the Adverse Party, are notified that you can be arrested for violating this order.**  
8 You can be arrested even if the person who obtained this Order invites or allows you to contact  
9 him or her. You have the sole responsibility to avoid or refrain from violating the terms of this  
10 Order. A violation includes but is not limited to contact in the form of verbal, electronic, and  
11 social media communications.

12 **You are further notified of the penalty for violation of an order. A person who**  
13 **intentionally violates:** an extended order is guilty of a category C felony (NRS 33.400) which  
14 is punishable by imprisonment in the state prison for not more than 5 years, and a fine of not  
15 more than \$10,000.00. (NRS 193.130) Each act that constitutes a violation of the extended  
16 order may be prosecuted as a separate violation of this order.

17 Under federal law, this protection order is valid and enforceable in all 50 states, the District  
18 of Columbia, U.S. Territories, and Indian Nations (18 USC § 2265.)

19 **Only the court can change this order.**

20 **ORDER TO LAW ENFORCEMENT**

21 Any law enforcement officer, with or without a warrant, may arrest and take into custody  
22 the Adverse Party, when the law enforcement officer has probable cause to believe that (a) an  
23 Order has been issued pursuant to NRS 33.400 against the Adverse Party; (b) the Adverse Party  
24 has been served with a copy of the Order; and (c) the Adverse Party is acting or has acted in  
25 violation of the Order. This arrest may occur regardless of whether the violation occurred in the  
26 officer's presence.

27 Any law enforcement agency in this state may enforce a Court Order issued pursuant to  
28 NRS 33.400 without regard to the county in which the Order is issued.
