

Because of the motion work and issues preserved on the case, it ended up starting as an attempt murder, and dealing as an obstruction misdemeanor.

My client was 14 years old. She was not receiving proper education in the Clark County Detention Center, nor was she safe, so she was allowed to be housed at the Juvenile Detention Center. The ability for a young female to receive a high school diploma or GED at the women's' prison is not as available as it is at the men's prison. As such, I was able to convince the Court not to sentence her until she completed her high school diploma at the Juvenile Detention Center. She ultimately received her Diploma and was able to begin college courses before getting parole. This case impacted me because I truly believe I impacted this young girl's future.

At the close of the case, I made a motion prior to the case going to the jury which dismissed punitive damages, as no evidence of punitive damages was presented to the jury. The Defendant was very wealthy, and as such, punitive damages could have been massive for him.

I have presided over revocation hearings, trials, pleas, arraignments, and standard status checks. I have also been responsible for approving arrest warrants as my time as an alternate judge.

I have worked as a CAP attorney where I represented abused and neglected children. I handle all traffic tickets for free, whether I know the individual or not. When I have court appointed clients who have other matters, such as bench warrants, I will handle those for them at no cost. While not a recognized program, myself and my children regularly prepare meals and necessities for the homeless community and drive around the city to provide food, clothing, and other necessities to those in need. While it is not a recognized program, we do it to help the community.

### QUESTION 47 Amanda Pellizzari – Applicant for Department 11

My career goal since college has to be a judge. I believe there are several things that distinguish me from the other candidates. While I respect the other candidates, the following are examples of my life experiences that I believe distinguish me from other candidates.

When I was in college, I decided I wanted to be a lawyer. However, I knew that the goal was to be a judge. I then developed my career to accomplish that goal. If you study my resume, with an explanation, you will see that everything about it reflects that.

While in law school it was obvious that my interest was in criminal law. However, my first job was in insurance defense. While inherently, I was not satisfied with that, I knew it was a step on my journey. At my first firm I took every experience that was offered to me, from arbitrations to depositions to trials to discovery – all to learn a necessary experience to be a judge – civil law. I was a female attorney in a mostly male office, yet usually treated as their secretary, not their peer. Despite the discouragement, I took every lesson and experience possible to learn what I needed to so I could handle the civil cases as a district court judge. While it was demoralizing at times, I stayed positive, studied every chance I could, and made sure that I knew the civil rules of procedure, as well as the caselaw, so that I could combat any adversary. Once I knew I gained everything I could from that firm, I decided to move on to a criminal firm.

My next experience was an associate at criminal defense firm. From the start I was thrown into a world I knew nothing about. I was approved to be a public attorney in municipal court even though I was lacking the minimum qualifications. From my first week there I showed up to court handing arraignments, pleas, revocations hearings, and trials – having very little experience in what I was handling. Despite that, I studied and did what I needed to so that my clients were getting the best representation possible. Once I left that position, I was asked to become an alternate judge.

## QUESTION 47 Amanda Pellizzari – Applicant for Department 11

I then decided to finally do what I had made a goal of mine early on. I decided that by 30 years old I would have my own law firm. I had to take on any case that would bring in income to support my family. When I was asked to be an alternate judge in municipal court, that meant giving up any case that I could defend in that court. As a sole practitioner, handling cases in Municipal court was a large source of income. However, I took myself off any municipal court case, and for over the past several years, I have rejected any Municipal court cases. Because my goal since law school has been to be a judge, I knew that the monetary benefit of handling municipal cases ultimately would be insignificant to my final goal – to be a judge. I have rejected all municipal cases in exchange for the \$100 per session I earn every time I sit on the bench as a municipal court alternate judge.

As an alternate judge, I have been told by the staff that I am the first person they go to when they need an alternate. I have been told that I get through the calendars efficiently, I minimize the work for the clerks, and that I hold the attorneys to a standard of being on time and prepared.

When you look at my resume you see a trend of 2+ years at any job, with the exception of working for myself. I worked at a civil firm learning while studying. I have handled more criminal sentencings than I can count and have worked on more civil cases than I can count.

I truly Feel that I am as well rounded as anyone could be to be a district court judge. In addition to my legal interest, I was also a psychology major, and focused my entire time in college in forensic psychology. I am very knowledgeable about mental illness and mental health

and understand how important it is to understand the mental impact on everyone – especially people who are victims of crime or accused of crime.

Aside from my professional experience, my life experience qualifies me. I am not a person who had my life handed to me to be a judge. From the time I was in high school I worked to do that. I had jobs since I was old enough to work, and only did school and jobs throughout my early adulthood, and once I got to law school had my eye on the prize of being a judge.

My history prior to law school was full of adversity, poverty, and learning at a young age that it was all on me to make something of myself without having anyone in my corner.

Everything I have accomplished has been completely due to my own hard work.
