ORDER

WHEREAS, on October 6, 2008, this court entered an order directing that the performance standards for attorneys providing indigent defense be implemented effective April 1, 2009; and

WHEREAS, this court's order also granted the request by Washoe County and Clark County to extend the time to complete a weighted caseload study to May 15, 2009; and

WHEREAS, on March 23, 2009, this court received a letter from Washoe County and Clark County requesting an extension for implementation of the performance standards until July 1, 2009, and an extension of the deadline for the weighted caseload study until August 15, 2009; and

WHEREAS, Washoe County and Clark County have not demonstrated good cause to delay the implementation of the performance standards; accordingly

IT IS HEREBY ORDERED that the motion for an extension of time to implement the performance standards is denied; and





IT IS FURTHER ORDERED that the Washoe County Public Defender, the Washoe County Alternative Public Defender, the Clark County Public Defender, and the Clark County Special Public Defender shall appear at the hearing scheduled for 1:30 p.m. on Tuesday, April 7, 2009, for a status report on the training being conducted with regard to the performance standards; and


IT IS FURTHER ORDERED that representatives from Clark County and Washoe County shall appear at the hearing scheduled for 1:30 p.m. on Tuesday, April 7, 2009, for a status report on the weighted caseload studies.


